#### No more paper

## RESEARCH METHODOLOGY

he research for the rankings in this edition was conducted rigorously and impartially by our team of research analysts in London, New York, and Hong Kong. Each year, we request information from thousands of firms, IP practitioners and their clients through interviews, email, and online surveys.

Before compiling the rankings, our analysts also conducted their own independent research, including an analysis of publicly available information (such as court or IP office data) and the existing research data we have. The aspects assessed for the firm rankings include expertise, workload, market reputation and record, outcomes achieved for clients, and unique strengths in each practice area. Judgements about which firms to include in the rankings, and which tier and practice area they should be in, take account of all this information.

Firms are ranked alphabetically in tiers, or as highly recommended or recommended. The total number of firms listed varies from jurisdiction to jurisdiction. For most jurisdictions, the rankings are split into prosecution and contentious work. However, in certain jurisdictions, we evaluate and rank firms for their trade mark or IP practice as a whole.

The prosecution ranking takes account of pre- and post-registration work, including office proceedings and portfolio management advice. The contentious ranking covers disputes (in and outside the courts) and enforcement work. Where appropriate, some firms have been ranked for both practice areas, and in a few European jurisdictions, we have a separate table for law firms that do trade mark filing and prosecution work.

These rankings are based on information available at the time the research was completed (February 2022). Except for firm name changes, any subsequent developments or information that could influence our rankings will be considered during the research for the 2023 edition of IP STARS, which starts in September 2022.

For the avoidance of doubt, the ranking tables do not suggest or indicate that the expertise or services of the listed firms are limited to the practice area in question, and Managing IP does not recommend or endorse any particular firm for IP work. No firm can pay to be included or to influence the results.

The IP STARS rankings are not influenced by any commercial relationship, including advertising, with Managing IP or IP STARS. There is no fee to pay to participate in our research. 

## Can trademarks be used as keywords by Google?

Manisha Singh and Niti Vyas of LexOrbis consider the findings of a Delhi High Court case that looks at how registered trademarks are used as keywords

n this age of technological advancements, our reliance on search engines particularly Google<sup>\*</sup>, for swift and accurate answers, has increased multi-fold. All the information we need is just one click away.

Search engines cater to our increasing need through several curated programmes, like the Google Ads Programme (Ads Programme) to generate revenue. The Ads Programme helps businesses to advertise when a potential consumer surfs on the web for products or services which are similar/identical to their product or services. However, with this comes a set of challenges. One such challenge with the Ads Programme is how it uses registered trademarks as keywords, leading to the diversion of internet traffic to competitors.

A single-judge bench of the Delhi High Court discussed this issue in the case of M/s DRS Logistics Private Limited & Others v Google India Pvt Ltd & Others. In this matter, the plaintiffs sought an ad interim ex-parte injunction against Google India Private Limited, Google LLC and Just Dial to restrain them from permitting third parties to use the plaintiffs' trademark 'Agarwal Packers and Movers' or 'DRS Logistics' as keywords or meta-tags on their search engines, as the same leads to diversion of traffic from the plaintiffs page to that of the competitor's webpage resulting in confusion about the source and infringement and/or passing off the owner's trademark.

The plaintiffs submitted that it owned the registered trademarks 'Agarwal Packers and Movers' and 'DRS Logistics'. In addition to the above, the plaintiffs had also succeeded in infringement actions against third parties, however, it was not able to get the third-party infringers to cease the use of its trademarks as keywords. "One challenge with the Ads Programme is how it uses registered trademarks as keywords, leading to the diversion of internet traffic to competitors."

Thus, the plaintiffs moved to court against Google and Just Dial. Google LLC and Google India Private Limited were made parties to the suit because of the Ads Programme. The confusion caused by the Ads Programme was supported by the affidavit of one of the aggrieved consumers, who availed itself of the services of a third party, assuming that it was the plaintiffs' services, and suffered a loss. Excerpts of the affidavit were reproduced in the judgment.

Additionally, Just Dial was also impleaded for using trademarks as keywords like Google, in a similar manner, thereby causing confusion and diverting traffic. However, it submitted that it did not use the mechanism of providing trademarks as keywords for triggering ads and the court upheld the same.

### Google's stance and the court's findings

The counsels for Google argued that the

Ads Programme of the defendants was an advertising service where any advertiser can create and display an online advertisement in relation to its website, which is inclusive of search-based advertising. Thus, when one conducts a search, two types of results will be generated one are 'sponsored search results' (the Ads Programme), and the second are the 'organic search results', generated automatically.

They further submitted that in order to create an advertisement, the advertiser had to provide the text and the search terms or phrases for the ads, which are known as keywords. When the chosen keywords are entered by a user as a search query, the relevant ad will be displayed in the search results. The keywords are treated as a backend trigger for the advertisement and are not displayed anywhere or in any manner tangible or perceptible to the enduser.

The actual display of the ads is determined by a combination of the bid amount, the relevance of the ad, the context of the internet user's search query and the expected impact of the ad formats and extensions. An advertiser only pays when a consumer clicks on the link. In addition to the above, Google explained that it also has a Keyword Planner Tool, a free research tool that allows the advertisers to gain statistical information and understanding of the kind of relevant words, expressions and combinations used in ads. In view of the same, it was submitted that Google was a mere intermediary, as it simply provides a platform, and all parts of the advertisement are selected by the advertisers themselves.

The court held that the contention that the Ads Programme falls under the provisions of Section 79 of the Information Technology Act, is unmerited.

Further, the defendants argued that the use of third-party trademarks as keywords did not amount to infringement or unfair competition, as per the Google Ads Trademark Policy which is applicable globally. The same policy offers a redressal of trademark infringement complaints as well.

The court held that Google is not an arbiter of third-party disputes and shall not investigate complaints of violation of trademark infringements. Even if Google investigates the complaints, it does not answer if the use of a trademark as a keyword is an infringement.

Further, it still shows that the usage of a trademark as a keyword amounts to a diversion of traffic from the website of the trademark owner to the webpage of the advertiser which causes prejudice to the trademark owner in terms of goodwill and reputation, as elucidated in the affidavit of the plaintiffs' complaint, and the same should be investigated by Google, as the advertiser is free-riding on the goodwill of the trademark owner through Google.

The defendants further argued that the use of the trademarks as keywords does not amount to use under the Trade Marks Act (Act). To constitute use of the mark as per the Act, the mark must be visually represented or printed in some tangible form to the end consumer and if the mark is used in relation to the goods or services or as part of any statement relating to such goods or services.

The defendants stated that mere use of the mark as a keyword that acts as a backend trigger does not amount to the use of the trademark. It was also submitted that the provisions of Section 2(2) must be read with Section 29(6) of the Act which specify forms of 'use' of the trademark that qualify infringement.

Such use of trademarks does not fall under the provisions of Section 29 read with Section 2(2) and thus, it does not satisfy the provisions of trademark infringement and passing off. Reliance was placed on a wide array of international judgments, wherein it was held that such invisible use of the mark, does not amount to infringement. However, the court did not agree with those due to the differences between the law in India and other jurisdictions.

Google, itself, had on several occasions submitted that Google Ads is an advertising programme. Accordingly, Section 29 includes advertisements as the use of trademarks, which can amount to infringement. Thus, the Ad Programme's trademark policy may be in tune with other jurisdictions, but not with that of India. The invisible use of trademarks will amount to infringement of trademark even in the form of keywords.

The defendants also submitted that the relevant classes of consumers who have access to the internet and use search engines like Google are likely to be literate

or semi-literate with a basic understanding of how search engine's function and a basic knowledge of the English language to understand the difference between the organic and ad results. This contention was also rejected by the court. It held that the average intelligence and imperfect recollection of an Indian consumer cannot be compared and equated with a consumer from UK or elsewhere. The court reiterated that the advertisements triggered by a third party will lead to confusion regarding the origin of the goods and services advertised.

After going through all the submissions, the court disposed of the interim applications. A set of directions were issued by the High Court against Google, as follows:

- Google shall investigate any complaint made by the plaintiffs alleging infringement causing a diversion of web traffic from the plaintiffs' website;
- Google shall investigate and review the overall effect of an ad to ascertain that the same is not infringing/passing off the trademark of the plaintiffs; and
- If it is found that the usage of the trademarks and its variation as keywords and/or overall effect of the ad has the effect of infringing/passing off the trademark of the plaintiffs, then Google shall restrain the advertiser from using the same and remove/block such advertisements.

The Delhi High Court has set an important precedent because it has decided on infringement caused by the invisible use

of trademarks as keywords especially when there is no provision of the Act dealing with such use.

Further, the court has directly held Google liable for its actions through the Ads Program, as it has enabled competitors to free-ride on the reputation and goodwill of trademark owners.

The directions of the court ordering Google to investigate the infringement complaints or take suo moto action will keep Google and the advertisers in check to avoid infringing on another party's rights. This order of the Delhi High Court is one in the right direction and sets a good precedent for similar matters relating to the usage of keywords. The decision provides respite to aggrieved trademarks owners and will hopefully be backed by more similar decisions in the future.

## Third year into Malaysia's Trademark Regime and the pandemic

**Eng Leong** of **Henry Goh & Co** discusses Malaysia's Trademarks Act 2019 three years on from being introduced

ust like a toddler that has just celebrated its second birthday (December 27 2019) and advancing from infancy towards preschool years, the 'new' Trademarks Act 2019 is no longer so new or a baby anymore.

Now into its third year of enforcement, the Act and the country's accession to the Madrid Protocol are reasonably expected to have found his sea-legs, although admittedly this would have been challenging amidst the turbulence of the COVID-19 pandemic that hit Malaysia (and the world) barely three months after the Act came into force.

The past year on the trademark front in Malaysia has been more of a survival mode with a wait-and-see approach.

### **Trademark growth**

Growth, in terms of the number of trademark applications filed and registrations granted in Malaysia, continues to climb, after a 10% dip in 2020 (compared to 2019). A total of 50,500 trademark applications were filed in the country in 2021, which translates to a strong growth of almost 20% from the previous year.

The healthy number of trademarks filed last year continues to signify that Malaysia remains an attractive country to invest in, particularly for foreign brand owners. In 2021, foreign applicants filed a total of 30,368 applications and 20,132 were by domestic applicants. Previously it can be observed that almost every year, there have always been an almost equal number of filings in both categories of applicants. This closing-of-the-gap trend was temporarily interrupted last year, most probably due to pandemic and its ensuing multiple but inevitable lockdowns (Movement Control Order) that

disrupted local businesses and the national economy in general.

Regretfully, a more detailed study into how trademark filing trends have been impacted by Malaysia's accession to the Madrid Protocol is not possible because MyIPO does not publicly make available a breakdown of the international application statistics – specifically as to how many, out of the 50,500 applications filed, designated Malaysia as a contracting party using the Madrid Protocol versus direct filings here.

At most, some informal information gleaned from a training presentation made by MyIPO showed that since the inception in December 2019 until October 2020, at least 3861 trademark applications did designate Malaysia as a contracting party. During this same 10-month period, about 67 international applications submitted to WIPO used MyIPO as an office of origin.

### Trademark administration

One silver lining, from the sudden environmental shift in how everyone works during the pandemic lockdown (and frankly also the indirect pressure of being a Madrid Protocol member), is that the efficiency and efficacy of the Trademarks Registry within MyIPO were also pushed to improve accordingly. When the officers are working from home, they can be contacted more easily over the telephone and they reply by email more promptly.

The most significant saving grace during the many lockdowns (when both MyIPO officers and trademark agents are working from home) is Practice Direction No. 2/2020 (and its subsequent variations) that came into effect on October 16 2020. The Direction was a clear example of MyIPO being proactive and practical, allowing trademark stakeholders to file a multitude of official forms via email and pay official fees using instant bank transfer.

In addition, hearings with MyIPO examiners continue virtually, by allowing technology to aide us during these times. Such a pragmatic approach by MyIPO towards how we work in this new normal really kept trademark cases moving and even the dreaded virus could not keep IP at bay.

Despite the work challenges of 2021, a total of 34,304 registrations were processed and granted, which is a respectable figure as

MyIPO continues to clear its work backlog. Even by way of a normal track application process, it now typically takes only about 14 months for a distinctive trademark to be officially registered in Malaysia, a significant improvement from the long wait of yesteryears. The only spanner thrown in the works is that the issuance of hardcopy certificates by MyIPO have slowed down significantly when most officers were working from home. It is strongly hoped that MyIPO will move towards issuing all certificates and written correspondence in digital format, which can be easily transmitted remotely.

In order to sustain and improve trademark growth, it is imperative to

maintain the momentum and the right direction that the pandemic has indirectly pushed us towards. We must keep the good practices and learn to be better from the bad ones. Thus, it was a real shame that the much lauded and valued email filing (with payment of official fees via bank transfer) ended in early November 2021, after it had worked so well for more than a year. It is understood that this is because the payment of official fees via bank transfer presented MyIPO with accounting challenges.

In lieu of email filing, the Registry pointed everyone to manual and online filing instead but for this to work well, there must continue to be a comprehensive support system at the Trademark Registry that eases the filing process and friendly towards the overall user experience.

For the last decade or so, MyIPO's IP online filing system has strived to serve that, although not without its periodic technical hiccups. The online system has gone through a few transformations, but not all necessarily qualify as an upgrade. Ample prior notification could have eased the transition because sudden regression to manual filing (at MyIPO counters) requires abrupt changes in work schedules and increases administrative work, not to mention that increased physical interaction with officers does not make good sense during another wave of the pandemic. In reality, the current trademark online filing system only allows limited types of trademark work to be filed wholly electronically, e.g. new application but most prosecution work has to be filed manually, including any take-over cases (renewal, recordals, etc.) where one is not the current trademark agent-on-record.

Fundamentally, there is a lack of readiness to support the usual electronic filing traffic. Many functions are in fact not ready for use and those supposedly ready are ridden with technical difficulties. Hopefully time will ease such administrative pain.

### **Trademark legislation**

As mentioned earlier, the Trademarks Act 2019 (TMA) and Trademarks Regulations 2019 (TMR) came into effect on December 27 2019 and all new trademark applications filed from that point onwards are governed by these new laws. TMA and TMR 2019 also govern the future

maintenance and dealings of trademarks registered under the previous law.

One of the more significant and exciting introductions made by TMA 2019 was the expansion of the types of trademark recognised for registration in Malaysia. The so-called non-traditional marks (NTM) have actually been considered conventional for a while now in many matured IP markets.

A quick search of MyIPO's database shows that approximately 230 NTM applications have been filed since 2019. This would include shape (about 130 applications on-record at the time of writing), colour (56), sound (7), scent (0), hologram (2), positioning marks (7) and sequence of motion (9); with the caveat that they must be signs capable of being represented graphically. However, 26 months down the road, it would appear that less than a handful of cases have been granted registration. Most are pending examination or pending appeal, and this shows that the Registry is taking a rather precautious approach towards the examination and acceptance of such NTMs.

Another measure taken by TMA 2019 to make trademark administration more efficient is allowing multiple classes to be designated within a single application, replacing the need to file one application per mark, per class. However, it would seem that the majority of trademark applicants still have a small appetite and prefer filing a single class in each application because in reality, there is no savings in official fees to file multiple classes in a single application because fees are still chargeable per class. Nonetheless, the possibility of dividing and merging of applications will still allow that trademark owners to better manage their portfolio at the appropriate times.

### Trademark accreditation

The Global Intellectual Property Centre of the US Chamber of Commerce (a constructive tool to help business and policy makers measure an economy's overall IP environment) in its 9th edition report ranked Malaysia 27th (same position as the year before) out of 53 countries surveyed; with an overall score of 51.61%. According to the report, key trademark areas that require improvement include the availability of frameworks that promote cooperative private action against online sale of counterfeit goods and protection of well-known marks.

In addition, the Office of the US Trade Representative (USTR) in their 'Special 301 Report' for 2021 commended Malaysia for the Special Internet Forensics Unit in our Ministry of Domestic Trade, Cooperatives and Consumerism responsible for IPR enforcement. However, in terms of trademark, the USTR pooled Malaysia with several other Asian countries like India and the Philippines for having slow opposition and cancellation proceedings. It is to be noted that the usual delay is in the final stage of the proceedings i.e. the review of the opposition and issuance of the grounds of decision by MyIPO, after parties have completed their exchange of arguments and documents.

### **Trademark litigation**

The pandemic has forced a number of court hearings and trials to be conducted virtually or in a hybrid format (usually judges in an empty courtroom and parties on a virtual platform) and indirectly, the number of cases heard, decided and reported has slowed down this past year.

It would appear that one of the first cases to be filed (in March 2020) and decided (in January 2022) under the TMA 2019 by the dedicated IP High Court in Kuala Lumpur was Bestinet Technology Sdn Bhd v MYFWM System Sdn Bhd & 3 Others (Case No. WA-22IP-22-03/2020). The plaintiff Bestinet has coined and registered the trademark 'FWCMS' for Class 09 goods, Class 35 and 42 services relating to a computerised management system of foreign workers.

The mark FWCMS' is an acronym for 'foreign workers centralised management system', developed by the plaintiff. The complaint before the court is that the registered mark has been infringed and/or passed off by the defendants' 'MyFWMs' mark in the provision of similar type of service.

The defendants pleaded that their 'MyFWMs' is merely a nomenclature of the official name of the first defendant company and that their foreign workers' management system is called 'SP4M'. developing and carrying out demonstrations to the Ministry of Home Affairs (a requirement before the Ministry considers and appoints a project supplier).

The trial proceeded in a hybrid manner during a lockdown and decided as follows:

- · The defendants counterclaimed that the plaintiff's trademark is invalid for non-use and non-distinctiveness. The court was satisfied that the plaintiff had provided sufficient proof that 'FWCMS' had been registered with MyIPO and had shown proof of its continued and positive use through the plaintiff's website, Facebook page, promotional brochures, various publications and photographs. The Court found the plaintiff had fulfilled the meaning of 'use' as defined in Section 7 of the TMA 2019.
- The court agreed with MyIPO for allowing the plaintiff's mark to be registered, having assessed the mark as a whole and found it to be of distinctive character (Section 2 of TMA 2019) and does not describe its goods or services. Thus, the defendants' claim of invalidation pursuant to sections 46 and 47 were dismissed.
- Having considered both parties' marks as wholes, the judge opined that the phonetic aspects of both marks do not carry any sensible speech or phonetic sounds. However, he concluded that the defendants' 'MyFWMs' mark is so nearly resembling the plaintiff's 'FWCMS' mark.
- Despite the similarity of the marks, the court opined that this does not automatically means there is a trademark infringement under Section 54. The court held that the 'likelihood of confusion on the part of the public' in Section 54(2) is one of perception and

not science. Since this section is in pari *materia* with Section 27(2) of the Singapore Trade Marks Act (Cap 322), the court must too consider 'extraneous factors' as laid down by the Singapore Court of Appeal and the court was convinced that the defendant's dummy website was created solely for demonstration to a group of officials from the Ministry of Home Affairs behind closed doors, that the subject matter and persons involved were subjected to the relevant confidentiality laws, and thus these officials do not fall within the spectrum of 'public' as envisaged by Section 54 of TMA 2019. The court concluded that the defendant did not infringe the plaintiff's trademark.

- In finding that the defendants have passed off and caused damage to the plaintiff's goodwill through unlawful association created by the defendants, the court observed that:
- There is no requirement for a trademark to be renowned before the user may be said to have acquired business goodwill.
- The plaintiff has acquired substantial goodwill in their trade and 'FWCMS' mark through extensive advertising and promotional activities and investments through the years when they conducted the services of foreign workers management system to the public.
- The defendants' defence that their 'MyFWMs' mark was coined from the acronym of the first defendant's name cannot be sustained.

2021 was a year that was fairly nondescript but there is strong hope that 2022 could still witness more rising from the ashes of the pandemic and find its footing in the realm of Madrid Protocol and TMA 2019. Watch this space.




