# Portal registration

- Before setting up a new account, it is advisable to ask the relevant individual(s) in your law firm, likely a business development or marketing colleague, to confirm if your firm already has an account.
- Register using your firm/company email address only (*no personal email address allowed*). We strongly advise firms to use a generic or team email account which can be used or accessed by anyone in the team or firm in case of staff departure.
- Create a single account for your firm/company
- Select from over 12,000 firm/company names or request for your firm or company to be added\*
- Primary user can add a secondary email address for correspondence only.
- We do not allow third parties, i.e. external marketing consultants, to create accounts in their own name, company name and email address. Third parties assisting firms are advised to use the contact details of the firm's employee, e.g. a partner or marketing manager.\*\*


